- Town Attorney Widner facilitated the strategic planning session. He noted that this process is one of the most important items the Board needs to do. A strategic plan provides the road map for priorities and the future.
  - o Each was asked to identify five key issue or problems.
    - Items identified for discussion:
      - Community relations and sense of bonding within town. Building a stronger sense of community.
      - Traffic on Hwy 9.
      - Trails/Trails Plan
      - Town "internal" roads/improvement beyond grading
      - Wildfire mitigation and enforcement
      - Protecting National Forest access
      - STR challenges
      - Internal road speeding
      - Bus stop safety
      - Population/demographic change tracking/monitoring
      - Cisterns-proactive

- Vision of understanding of what we want to be and who are. What residents want and what is our strategy to get there.
- Internal Challenges
  - Competitive Compensation package to attract candidates
  - Understand Town needs and staff needs
  - Housing
  - Understanding what the demands are related to new populations
  - Staff succession plan
  - Understand COVID impact on residents and staff.
- Long Range
  - Where do we want to be in competition with other towns? How do we market ourselves as a residential community of choice.
  - Annexing to grow tax base and attract areas to Blue River
  - Research potential feasibility of commercial zone
  - Proactive control of land surrounding town.
    - o Land purchases to protect residential footprint.
  - Tarn rights preservation/donut
  - Trail access plan
  - Demonstrate pride in what the community does offer (Park)
  - Enhance park
- 2021 Priorities
  - Fire Plan
    - o Mitigation; Cisterns
  - Hwy 9 safety
  - Land Use Planning
  - Park enhancements-work with landscape architect
  - Compensation packages and succession planning in writing and detail
