- I. Call to Order at 6:00 p.m.
- II. Roll Call Upon completion of the Roll Call Member Stuckey arrived at 6:05 and Trustee Dixon arrived at 6:15
- III. Approval of Agenda
 - A Motion was made by Eric Hann to approve the Agenda. The motion was seconded by Joe Hamlet. The motion passed unanimously.

 - Co-Chair Semmer requested a change to the Minutes concerning bullet point three under the Implementation Strategy.
